Step-3: Full Paper Submission

- The abstract should be uploaded by clicking the button “**Abstract Submission**” on conference website and filling the required details.
- The theme and subtheme under which the abstract is to be considered must be selected correctly.
- The presenting author must be listed as the first author.
- Acceptance would be communicated to presenting author within a week time along with the Paper id.
- Once the abstract is accepted, presenting author would be required to send their full Paper not exceeding 5000 words including tables and figures.
- Correspondence and proofs for correction will be sent to presenting author.
